USBMK-32GB - MASTER PACK FOR SITE

This kit provides the user with 25 incident report logs for CCTV evidence. The 32GB MASTER drive is to be kept on site and used for the users own backup of any incident until the authorities have finished with the evidence. If anything happens to the original evidence given to the authorities you have a backup as the DVR/NVR will usually have written over the evidence. After any case is finished then the incident on the Master drive must be deleted. 2 X Data Protection compliant CCTV A4 warning signs where you write the operators name & contact details with the permanent marker provided. This pack is designed to be used with USBEK-16GB which are the drives and evidence bags for incident downloads to be used by the authorities.

2 x CCTV Warning signs A4 size

1 x Permanent Marker for writing operators contact details on the signs

These 16GB USB drives are to be used to provide evidence to the authorities. Each pack is for 5 incidents and comes complete with tamper-proof evidence bags.

Once closed they can only be opened by cutting open and destroying the bag. They have a tear off strip which will be kept by the site for the audit trail of evidence.

1 x Security Ink pen (ballpoint) for writing in the incident logbook. Tamper-proof, Waterproof and Fade-proof ink.

1 x 1 x A5 Zip Bag Mesh reinforced clear PVC. To keep in USBs and Pen safe on site.
